

CAMPING REGULATIONS 234
in Legnickie Pole at 7 H. Brodatego street

§1

GENERAL PROVISIONS

1. The campsite in Legnickie Pole is open all year round.
2. The stay and use of the campsite are subject to a fee. A detailed price list specifying the amount of individual fees is attached as Appendix 1 to these regulations.
3. Any closure of the facility on a given date is decided by the Director of the Municipal Cultural and Sports Centre in Legnickie Pole. This information must be made public.
4. The owner of the facility is the Legnickie Pole Commune, and the manager is the Commune Center of Culture and Sports in Legnickie Pole.
5. These regulations specify the rights and obligations of guests regarding their behavior during their stay at the Camping and the method of using the technical devices and equipment available.
6. The principles of the Regulations are intended to protect the rights of all guests of the Campsite.
7. These regulations also specify the rights and obligations of the Staff.

§2

DEFINITIONS AND OCCURRING PHRASES

1. Camping - also known as Facility, area located in Legnickie Pole at 7 H. Brodatego street. It includes: cottages, a camping site, a place for campers, a fireplace, toilets and a reception. The entire area is fenced, and there is a free parking lot in front of the entrance gate.
2. Administrator - Municipal Center of Culture and Sports in Legnickie Pole (hereinafter referred to as GOKiS), located in Legnickie Pole at 6 Henryk Pobożny Square.
3. Staff - otherwise known as Employees, people employed at the Municipal Center of Culture and Sports in Legnickie Pole, delegated to operate the Camping.
4. Tourist - a registered person using the paid services of the Campsite.
5. Guest - a person using the Camping's services as part of a daily stay and separate consents or agreements concluded with the Manager.
6. Reception - a building at the entrance gate to the Campsite, where staff are on duty.
7. camper site - a separate and marked green area within the Campsite.

§3

REGISTRATION ISSUES

1. The reception is open during the season, according to the schedule available at the Campsite and on Facebook or the website.
2. In justified matters, you can contact the Camping staff by phone according to the schedule. The contact telephone number is available in a visible place at the Campsite and on the reception door.
3. Immediately after arriving at the Camping, the tourist is obliged to register at the reception in order to enter the Registration Book. During registration, the person must present an identity document and provide the type of accommodation/stay and the number of people arriving with him/her.
4. Every person arriving at the Campsite is obliged to report to the reception.
5. When checking in at the cottage, the current water meter reading is recorded.
6. The staff may refuse to accept a guest who, during the previous stay, grossly violated the regulations of the Campsite, causing damage to the property of the Campsite, guests or personal injury to the guest, staff, or otherwise disturbed the peace of the guests' stay or the operation of the Campsite.

7. The fee for the entire stay and the deposit for renting the house is payable upon arrival. In exceptional situations, it is possible to pay the fee on the day of departure. Upon check-out, the deposit is returned minus the water fee based on meter readings.
8. Payment for the stay is made **by card or cash in Polish zloty (PLN)** .
9. The deposit for renting the house is paid **in cash in Polish currency (PLN)**.
10. The currently valid price list is available in a visible place in the Camping area and at the reception, as well as on the GOKiS website .
11. The campsite accepts the following cards: PFCC, ACSI, ADAC and CAMPING CARD.
12. A receipt is issued for the paid stay costs. A VAT invoice can be issued upon request. This fact must be informed before the staff issues a receipt.
13. The received receipt or VAT invoice entitles you to stay at the Campsite. You must keep it for inspection throughout your stay.
14. The stay in the cottages starts at 14:00 on the first day of your stay and ends at 10:00 on the day of departure. Staying longer at the Campsite is counted as another day of stay.
15. The stay at the tent and camper site lasts 24 hours from the moment of check-in.
16. Unregistered persons (visitors) may stay at the Camping from 8:00 a.m. to 9:00 p.m., after prior notification of this fact at the Camping reception.
17. Persons who are not tourists and want to use a place prepared for a bonfire or a shelter with barbecues are obliged to apply in advance for their use, sign an appropriate agreement with GOKiS in Legnickie Pole and pay a fee.

§4

OBLIGATIONS OF THE MANAGER

1. The campsite provides:
 - a) conditions for full and unrestricted rest of the guest, subject to §9, point 5-7,
 - b) safety of stay, including the security of keeping information about the tourist secret,
 - c) professional and courteous service in the scope of services provided,
 - d) technically efficient service. In the event of defects that cannot be removed, the staff will make every effort to change the location, room or otherwise alleviate the inconvenience, if possible.

§5

USE OF THE CAMPING

1. It is prohibited to bring flammable fuels, explosives, etc. to the Campsite.
2. The location of the camping equipment and the guest's vehicle is determined by the staff.
3. Stay is allowed only within the space designated for this purpose.
4. It is prohibited for a guest to change the camping pitch without prior permission from the staff.
5. Minors should be under the supervision of their parents or persons who are directly responsible for them. Children may use the equipment, playground and services at the Campsite only in the presence of supervising adults. The camping declines any responsibility in this regard.
6. For reasons of fire safety, open flames are allowed only in designated areas and after prior notification of this fact at the reception.
7. One car is parked for a fee for each house, trailer or tent. Other vehicles should be parked in the parking lot in front of the entrance gate. In the case of low occupancy of the facility, an exception to this rule may be made with the consent of the staff and appropriate payment.
8. Guests and tourists driving around the Camping area are obliged to exercise particular caution. The maximum speed of vehicles is 5 km/h.
9. The parking lot adjacent to the campsite is free and unguarded.
10. It is prohibited to park vehicles (for shorter or longer periods) on the roads of the Campsite, unless the consent of the Staff has been granted.

11. It is forbidden for people to enter the Camping area by car without making the appropriate payment. The exceptions are: technical service, staff and other persons with the consent of the Manager.
12. It is prohibited to cross fences both internally and externally.
13. Wi-Fi is available at the campsite for guests. The password is provided by the Staff.
14. It is prohibited to conduct any commercial activity within the Campsite without the consent of the owner or Manager.
15. It is strictly forbidden to rent trailers, campers, etc. to third parties or lend them to obtain financial benefits. Violation of this point of the regulations will result in immediate expulsion from the Campsite.
16. Before leaving the Campsite, the guest is obliged to clean and leave the place where he stayed intact.
17. In the case of renting a cottage, the cottage must be left in a non-deteriorated condition before departure. For permanent damage and dirt, a fee will be deducted from the deposit.
18. Before leaving the campsite, the guest is obliged to check out.
19. There is an archery track perpendicular to the internal road. Training takes place there on selected days. You should be especially careful during them.

§6

USE OF TECHNICAL DEVICES AND EQUIPMENT

1. The campsite guarantees guests the use of equipment of a standard consistent with the requirements of the facility category.
2. Tourists can use the " Camper System" - the machines allow for paid electricity, water and waste disposal.
3. Guests and tourists can use electrical and municipal devices as well as public equipment located at the Campsite. Devices and equipment may only be used for their original purpose and at your own risk. After using them, leave them clean.
4. Washing dishes and washing clothes may only be done in specially designated areas.
5. It is prohibited to wash the car, change the oil in the vehicle, etc. at the Campsite.
6. Washbasins, showers, urinals and toilets must be used appropriately and appropriately for their intended purpose. Guests and tourists must be aware that these are sanitary facilities shared by all camping users. You should take care to leave everything tidy.
7. Connection to and disconnection from the electrical installation (electrical box) is made with the consent and supervision of staff.
8. Any defects arising during the use of the Camping property should be reported to the staff on an ongoing basis.
9. Tourists and guests are financially liable for any damage or destruction of the equipment and technical devices of the Camping resulting from their fault or the fault of people visiting it.
10. For fire safety reasons, it is prohibited to use electrical devices that are not part of the room or cottage equipment in the rooms and cottages of the campsite, with the exception of chargers.

§7

LIABILITY FOR PROPERTY

1. The campsite is monitored in public areas, except for toilets.
2. The manager is not responsible for cars, valuables and personal belongings left at the Campsite without the owners' supervision. Please exercise due care when locking trailers, tents or houses and secure valuable items appropriately.
3. Items and objects left by the departing guest and found by the Staff will be stored for a period of 1 month.

§8

ENVIRONMENTAL PROTECTION

1. To dispose of garbage, there are baskets placed around the campsite.
2. It is prohibited to throw away garbage outside the designated bins.
3. Guests are obliged to keep the places they use neat and clean.
4. Guests are obliged to protect all plants located at the Campsite.
5. It is prohibited to break branches, destroy (e.g. hammer in nails) or cut down trees.

§9

ORDER AND PEACE

1. Guests are obliged to maintain order and peace.
2. All persons staying at the Campsite are subject to night curfew from: 22:00 – 6:00.
3. The main entrance gate is closed from 10 p.m. to 6 a.m. The gate is opened during these hours only after telephone contact with the staff.
4. The staff may ask a person to leave the Camping area if their behavior disturbs the peace or threatens the safety of other people staying in the Camping area.
5. The campsite, apart from recreational and tourist activities for tourists, is also a place for cultural and recreational events, concerts and other events organized by the Manager and other municipal units.
6. On the days when the above-mentioned events take place, the Manager reserves the right to change the rules described in these regulations regarding: night silence, increased noise levels, accessibility of the facility, and other difficulties related to the organization of these events.
7. Tourists and guests are informed well in advance about larger events taking place at the Campsite. This information is provided to tourists during check-in and posted in a visible place.

§10

OTHER RULES

1. Tourists and guests are obliged to comply with occupational health and safety and fire safety regulations.
2. Pets may stay at the Campsite for a fee, but the guardian must have a valid vaccination certificate and safety measures in the form of a leash, collar, muzzle and other measures commensurate with the animal's species and breed. The guardian is obliged to ensure cleanliness and remove excrement.
3. The guest reports to the staff damage, failure of installations and equipment, as well as any failure to comply with these Regulations.
4. The Manager or the Staff are not responsible for any accidents or injuries occurring at the Campsite due to the fault of guests.
5. Guests may report any complaints regarding the operation of the Campsite to the staff.
6. At the reception there is a notebook of complaints and requests, where tourists and guests can enter their comments regarding the services provided at the Campsite during their stay.

§12

FINAL PROVISIONS

1. The Guest is obliged to comply with all provisions of these Regulations.
2. In the event of non-compliance with the prohibitions set out in these Regulations, the Manager or Staff may refuse such a person to continue staying at the Camping premises.
3. Violation of the principles of these regulations and the norms of tourist coexistence is assessed by the staff and may deprive the tourist of the possibility of further stay at the Campsite without the possibility of refunding the costs of the stay.
4. The final interpretation of these regulations and the decisions made by the Manager are final.
5. In matters not regulated in the Regulations, the provisions of the Civil Code shall apply.

1. The rates given in Appendix 1 are gross rates.
2. Free WiFi is available on the premises.
3. Service Station fees: 1 hour of access to electricity – 1 PLN, 10 liters of water – 1 PLN
4. In the case of renting a cottage:
 - a) A deposit of PLN 500 is required upon check-in.
 - b) The water fee is collected from the deposit based on recorded meters at the currently applicable rate.
5. For stays over 7 days – 10% discount
6. Payments are possible **by card and cash in Polish zloty (PLN)** .
7. Guests with a PFCC, ACSI, ADAC and CAMPING CARD receive a 5% to 10% discount depending on the length of their stay.
